"At Exmouth Community College we aim to enable students to develop fully their personal talents and academic abilities in a happy and supportive environment."


This document explains how we spend our Pupil Premium Funding to make our Mission Statement a reality for **all** young people.

For students entitled to free school meals, children in care, children of parents in the armed forces, the school receives the pupil premium. For 2016/2017 this will be £935 for students on free school meals, £1,900 children in care and £300 for children of parents in the armed forces.

Students on roll at the annual census who have been on free school meals in the last 6 years will also gain extra funding for the College.

The College has a <u>Pupil Premium Pledge</u> which sets out clearly the expectations of each lesson and the actions teachers will take to ensure students make the necessary progress.

The Pupil Premium Pledge is as follows:



Assess and mark books first

- Ensure students respond appropriately to feedback and know how to improve
- Track the progress for every child and regularly moderate their work

Suitable and appropriate planning for students which will stretch and challenge

- Encourage independent learning and the development of independent thinking skills
- Target support effectively in the classroom so students make appropriate
 and expected progress

Provide enriching experiences through extended learning and opportunities

- Encourage students in the PP category to engage in trips and aim to increase the percentage accessing trips
- Encourage students to join extended learning opportunities in your department

- Actively developing both literacy and numeracy skills in every lesson
- Use a range of teaching and questioning techniques to engage a variety of learning styles

Reward and positively reinforce achievement

- Highlight achievements to parents/carers
- Celebrate success and a culture of respect in every classroom

Expectations are high for every student

- Instil and promote positive behaviour for learning in every classroom
- Modelling examples of good work and use as a benchmark for
 achievement to others.

Priority One - Securing Success For All Young People

When students enter Exmouth Community College we ensure we know and understand the starting points for their academic progress through our thorough transition process and partnership work with Exmouth Primary Schools. We gain valuable information from their Primary Schools and additionally we carry out several important baseline assessments such as student reading ages and CAT4 testing. This acts as a basis for focussed tracking in student attainment and progress, ensuring the impact of outcomes from effective teaching and learning are maximised and cost effective.

The pupil premium will be spent on ensuring that <u>all students</u> are making progress in the key skills required to succeed at the College and ensure they are properly prepared for each stage of their education.

The most important skills are;

- Reading
- Speaking
- Writing (including spelling)
- Use of Number.
- Listening and auditory processing

Without these skills students will not reach their potential.

For students who enter the school with reading ages well below their chronological age we will deliver a personalised programme of "catch up" to help them improve on this vital skill. The catch up reading and literacy programme will be based on regular intensive small group sessions.

Alongside this we want to encourage students to read for pleasure. Ensuring that both young people and their parents have access to high quality stimulating reading materials is a priority.

Within the curriculum we pay for additional staffing which can help us design learning which is personalised to the needs of individual and to groups of learners.

Throughout their time at Exmouth Community College, we will intervene to support students who fall behind in these core skills. This will be done through interventions such as:

- Small group interventions
- One to One Tuition
- Additional support classes, either after College or during Holiday time (i.e. Summer School, Easter Revision and Saturday 'Aim Higher' sessions)

In recent years, we have found this particularly effective in helping students gain the skills and confidence to succeed.

Data will be monitored using 4Matrix and SIMs which not only demonstrates progress and impact but can also help demonstrate value for money. The information will be used by staff to evaluate and target progress within departments. The impact of pupil premium is recorded both departmentally through the Department Strategy and Impact document and in SIMS Intervention Tracker. Impact will be shown on an annual basis through our College Pupil Premium Report. This is published every September on the College website.

The impact of the pupil premium and the interventions used for students in care is recorded in detail through their Personal Education Plan which is completed every six months by the College in conjunction with all agencies.

Priority Two - Supporting students Well-Being and Behaviour

For many students becoming a teenager is not the easiest of times. This can lead to emotional difficulties both at home and at College. We believe that employing high quality staff to help students overcome their particular barriers to learning is essential. There are many students who do rely on this to succeed at College and without this personal approach will become disengaged from College. This mentoring will mean supporting students, emotionally, including counselling, but also ensuring that they are challenged to work hard, succeed and overcome their barriers to learning. Some of this work involves helping students to raise their aspirations. Therefore some funding will be targeted at helping students identify future opportunities. For example, opening their eyes to the possibilities of further and higher education through the Careers Fair and external speakers.

Priority Three - Ensuring Equality of Access to the Curriculum

A key aspect of our ethos at Exmouth Community College is our belief that we need to develop memorable learning experiences through quality teaching. This includes curriculum trips and visits. We also believe that all students benefit greatly from a residential experience.

Our after College youth programme provision is extensive and inclusive. The pupil premium will be used to support students whose families are on low incomes to access the programme by contributing up to 50% towards costs. The College also follows DfE guidance which states that parents who meet the free school meal eligibility criteria are exempt from paying the cost of board and lodgings on residential trips.

Similarly whilst Activities Week has been designed to be very cost effective we understand that for some students this still could be a barrier.

A key part of our mission statement focuses on developing the talents of the students. We believe that talents such as sport music dance drama will only develop into a lifelong passion by providing a high quality extended curriculum.

The pupil premium will also help <u>all</u> students access this curriculum and help students discover their talents.

Priority Four - Supporting Parents

Bringing up teenagers is never an easy time. The additional stresses provided by financial worries will also impact on this. We believe that providing high quality support to parents of students who are finding it difficult to progress at College can impact greatly on their success at College. We provide regular meetings where parents can discuss their concerns and jointly identify strategies which can help students succeed at College and at home.
